It was agreed to go ahead with the quote.  The noticeboard for Daisy Hill has been purchased. The clerk bought this using the Parish accounts to reclaim the VAT, resulting in a cost of £156.66 ex VAT.  Inspections have been conducted at Cross Lane, and the following actions have been agreed upon:  — A notice for improvement will be issued for plots P6, B8, B9, and D4.  — Plots D5 and D7 will be monitored.  — Eviction notices will be served for plots P9 and P11.
